Peer Review Council

Change in Statutory Language Related to Patients Compensation Fund Peer Review Council Expenses:

655.275 (10): MEMBERS' AND CONSULTANTS' EXPENSES. Any person serving on the council and any person consulting with the council under sub. (5) (b) shall be paid ~~\$50 for each day's actual attendance at council meetings, plus actual and necessary travel expenses.~~ **at a rate established by the Commissioner of Insurance in administrative rule.**

Intent of the Statutory Language Changes:

In the peer review process, consultants are asked to review claim files and make a recommendation to the Peer Review Council as to imposing a surcharge for malpractice insurance. The process is intended to provide a means to levy additional fees against those providers with poor experience, or multiple medical malpractice claims. Peer Review needs to be able to compensate medical experts at a reasonable rate if participation in the review process by these experts is to be expected.
