PROBLEM

Wisconsin Works (W-2) agencies are required, under administrative rules (DWD 12.15), to make an initial assessment of each participant prior to placement in a W-2 employment position (trial jobs, community service jobs (CSJs) and W-2 Transitions) and to develop an employability plan for a W-2 participant which includes required work and education and training activities. It is clear in the statutes that participants in CSJs and W-2 Transitions may be required to participate in 10 and 12 hours per week respectively in education and training activities. However, it is not clear that participation in appropriate education and training activities determined by the W-2 agency's assessment and outlined in the individual's employability plan for all W-2 participants should be paid for by the W-2 agencies under the Wisconsin Works Implementation Contract including those participating in unsubsidized employment and trial jobs.

PROPOSED CHANGE

Amend s.49.147(2)(a)2 and (3)(am), Stats., to make clear that a W-2 participant who is participating in unsubsidized employment or has been determined capable of participating in unsubsidized employment and is receiving case management services or who is participating in a trial job must have his or her basic education needs assessed. If basic education (e.g., GED/HSED classes) is needed and the client wants to participate in basic education, the W-2 agency must include this in the individual's employability plan and must pay for identified basic education services out of current contract dollars.

EXPLANATORY NOTE

The Department's intent is that W-2 agencies complete an assessment for all W-2 participants, including those who are participating in unsubsidized employment or determined capable of participating in unsubsidized employment and receiving case management services, to determine basic education needs and, if basic education activities are needed, that W-2 agencies pay for the needed activities.


