The Medical College of Wisconsin has requested a budget-neutral statutory language change which would transfer \$400,000 from the Medical College's Area Health Education Centers (AHECs) appropriation (20.250 (1) (c)) to the University of Wisconsin System's AHEC appropriation (20.285 (1) (b)). If the statutory language change is approved, the Medical College would receive a \$400,000 payment from the UW System to cover costs incurred from implementing its share of the AHEC program.
