Subject: Drafting Requests—Department of Corrections (DOC)

Please draft each of the following items as separate budget drafts:

- ✓ allow the state to contract with private prisons within the state;
- ✓ require DOC to lapse \$2,250,000 from appropriation 20.410(1)(gt) to the General Fund by June 30, 2000;
- ✓ require DOC to lapse \$750,000 by June 30, 2000 and an additional \$150,000 by June 30, 2001 from appropriation 20.410(1)(kc) to the General Fund;
- ✓ create a DOC SEG annual appropriation entitled Computer Recycling that contains \$500,000 in FY00 and FY01 from the Recycling Fund;
- ✓ create a PR-S annual appropriation entitled Victim Services within DOC with expenditure authority of \$204,000 in FY00 and \$222,200 in FY01, require the Department of Justice (DOJ) to transfer funding in these amounts to DOC from the Victim of Crime Act (VOCA) federal grant (Department of Justice appropriation 20.455(5)(mh));
- ✓ delete the requirement the Prairie du Chien Correctional Facility become a juvenile facility on June 30, 1999;
- ✓ change Racine Youthful Offender Correctional Facility from medium security to maximum security in LRB draft 335/1.

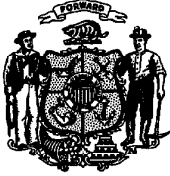
