Under current law, an individual is eligible for Wisconsin works (W-2) if the W-2 group of which the individual is a member meets certain income and asset limits and the individual meets certain other criteria. Currently, the individual remains eligible until the W-2 group's assets exceed the asset limit for at least two months or until the W-2 group's income is *expected* to exceed the income limit for at least two *consecutive* months.

Under this bill, an individual remains eligible for W-2 until the W-2 group's assets are *expected* to exceed the asset limit for at least two consecutive months, as is currently the case with respect to the W-2 group's income.

SECTION 1. 49.145 (4) of the statutes is amended to read:

1           49.145 (4) REVIEW OF ELIGIBILITY. A Wisconsin works agency shall periodically  
2 review an individual's eligibility. The individual remains eligible under sub. (3) until  
3 the Wisconsin works group's assets exceed the asset limits for at least 2 months or  
4 until the <sup>or</sup> income of the Wisconsin works group is expected to exceed the asset or  
5 income ~~limits~~ limit under sub. (3) for at least 2 consecutive months.
