Under current law, any agency, such as the department of regulation and licensing (DORL), may accept payments made by credit cards approved by the depository selection board. In addition, DORL is specifically allowed under another provision of current law to accept payment of credential fees by credit card. This bill eliminates the provision under current law that specifically refers to DORL.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 3 Section 2. 440.055 (2) of the statutes is amended to read:
