### Distribution of the History of Wisconsin (Historical Society)

#### CURRENT LAW

The Historical Society is provided \$35,000 GPR annually in a separate, continuing appropriation for the distribution of a six-volume set of the history of Wisconsin to each of the currently existing public middle school, junior high school, senior high school, technical college, state-supported college and university libraries, all public libraries and upon their request, to county and local affiliated historical societies in this state. Private and parochial school libraries, in addition to any other interested residents of this state, may receive copies at cost. Since 1973, state funding has been released to the Historical Society for this purpose, in accordance with the production schedule.

#### GOVERNOR

#### MODIFICATION TO BASE

Delete \$35,000 annually and any statutory provisions related to the distribution of this six-volume history of Wisconsin. Because an estimated \$135,000 of spending authority from prior years remains available in this continuing appropriation, these monies would lapse to the general fund upon repeal of the appropriation.

**Explanation:** The final volume of the set was completed in 1998 and has been distributed to each of the institutions required under state law. Officials at the Society indicate that the financial transactions related to the distribution of the history books have been completed and that funding for this purpose will not be necessary in the upcoming biennium.
