#### Northern Great Lakes Center and H.H. Bennett Studios (Historical Society)

[LFB 1999-01 Budget Summary: Pages 361 and 362, #2 and #4]

#### **CURRENT LAW**

The Historical Society is required to operate and maintain the historic sites known as Stonefield Village, Pendarvis, Villa Louis, Old Wade House, Madeline Island, Old World Wisconsin and First Capitol. No historic site may be closed without specific authorization to do so from the Legislature and the Governor. Annually, by December 1, the Director of the Society is required to submit a report to the Joint Committee on Finance regarding program revenues and expenditures for each historic site and the condition of the sites.

State GPR funding is provided to operate the H.H. Bennett Studios under the Historical Society's Historic Sites Division. This funding was first provided under 1997 Act 237 to create the Studios as a new historic site; however, the Studios was not statutorily designated as a site.

State GPR funding is provided to operate the Northern Great Lakes Center (NGLC) under the Society's Executive and Administrative Services program. Segregated funding from the state conservation fund is also provided to operate interpretive programming at the NGLC; the Center is not a designated state historic site.

Provide that the Society would operate and maintain the Northern Great Lakes Center as an historic site.

#### **MODIFICATION**

Designate the H.H. Bennett Studios as a state historic site, rather than the Northern Great Lakes Center.

Explanation: Staff at DOA indicates that the Northern Great Lakes Center was inadvertently designated a state historic site, rather than the H.H. Bennett Studios. Officials at the Historical Society indicate that the one-year-old NGLC should not be designated a state historic site, but the 19<sup>th</sup> Century Bennett Studios should be designated an historic site. This modification would not alter the proposed funding levels for the Bennett Studios or NGLC, and both entities would be administered by the Division of Historic Sites, as proposed under the bill.

8. Because the Society and Governor's Office have not yet acted to secure funding for this project, the Society may not be ready to begin the project at the start of the next biennium. Under current law, any state agency may request additional program revenue position authority through the process established under s. 16.505. If the Society is able to secure funding for the project, the Committee could authorize positions at that time.
