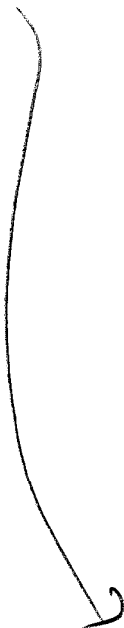

# 1999 BILL

1 **AN ACT to renumber** 44.015 (6); and **to create** 44.015 (7) of the statutes,  
 2 **relating to:** authorizing the Wisconsin state historical society to contract with  
 3 the Wisconsin History Foundation.

### *Analysis by the Legislative Reference Bureau*

This bill authorizes the Wisconsin state historical society to contract with the Wisconsin History Foundation, Inc., a nonprofit corporation established to assist the society, to administer the society's membership program.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*
