Analysis by the Legislative Reference Bureau RETIREMENT AND GROUP INSURANCE

This bill provides that the costs of legal services authorized by the employe trust funds board for the administration of the employe trust fund must be paid from an appropriation to the department of employe trust funds (DETF) for the purposes of the benefit plans administered by DETF.
