## Deletion of Obsolete Appropriation (Circuit Courts)

### CURRENT LAW

Section 20.625(1)(k) of the statutes is an appropriation for drug court costs; local assistance. The appropriation has expenditure authority of \$160,000 PR annually. However, the appropriation language specifies that no money may be encumbered after June 30, 1997.

### GOVERNOR

No provision.

### MODIFICATION

Delete \$160,000 PR annually and repeal the appropriation for drug court costs; local assistance.

**Explanation:** 1991 Act 39 (the 1991-93 biennial budget act) created an appropriation under the Circuit Courts, with a sunset date of June 30, 1993 (later extended to June 30, 1997), to receive anti-drug abuse monies administered by the Office of Justice Assistance to reimburse Milwaukee County for certain operating costs of a speedy trial drug court. **Federal law concerning the use of the anti-drug abuse funds limits grants (with some exceptions) to four years and anti-drug funding is no longer available for this purpose.** Since the appropriation sunsetted on June 30, 1997, it should be repealed.
