Full-time District Attorneys in Richland and Rusk Counties

Motion:

Move to provide \$4,500 GPR and 0.05 GPR position annually for Richland County, and \$17,900 GPR and 0.20 position annually for Rusk County to make the district attorneys in those counties full-time. Modify the statutory language regarding district attorneys to reflect this change.

Currently, district attorneys are part-time positions in Buffalo, Florence, Forest, Pepin, Richland, Rusk, Trempealeau and Vernon counties. The district attorney in Richland County is 0.95 FTE, and the district attorney in Rusk County is 0.80 FTE. This motion would make the district attorneys in Richland and Rusk counties full-time, and would modify the statutes to reflect this change.
