

Motion:

Move to allow DNR to lease lands in the Northern Highland-American Legion State Forest on Statehouse Lake in the town of Manitowish Waters for the North Lakeland Discovery Center for terms not to exceed 30 years.

Note:

Under current law, DNR may not lease lands from state forests or parks for terms greater than 15 years. Exemptions have been statutorily granted for 30-year leases on lands at Rib Mountain and Willow River state parks and the Kettle Moraine state forest for the YMCA Camp Matawa.
