Re: Child Abuse and Neglect Prevention Board

On May 6, 1999, the Joint Committee on Finance took executive action on the Child Abuse and Neglect Prevention Board. The Committee adopted Alternative 3a from paper #275. This action maintains current law regarding the Board's authority to spend revenue from the sale of the special license plate.

However, I understand that the accountants in DOA and DHFS are indicating that the Board does not have the authority to expend the interest earned on the revenue generated from the sale of the special license plate. It was my understanding that current law does provide that authority and it was the intent of the Committee in adopting Alternative 3a that the Board be authorized to spend the interest earnings from the sale of the license plate. Therefore, the draft should ensure that the Board is authorized to expend only the interest earnings from the sale of the license plate.

Let me know if you have any questions on this matter. Also, would you prefer that I submit drafting instructions to you via email or fax? I am willing to do either, depending on your preference. Let me know. Thanks.
