	On Tuesday, May 18, 1999, the Joint Committee on Finance took executive action on 1999 AB 133 related to community aids and DHFS children and family services issues. Under both of these sections, the executive action was taken from the base (current law). As a result, unless provided for in the action taken by the Committee's action, everything in the Governor's bill is removed. The Committee has not yet taken up kinship care and brighter futures. Those issues will be taken up on TANF day. The following changes should be drafted to AB 133.

B. Statutory Provisions

In addition, beginning July 1, 2001, require DHFS to distribute excess federal foster care funds only to those counties (other than Milwaukee County) that are making a good faith effort, as determined by DHFS, to implement SACWIS. (This provision would modify the Governor's recommendations to reflect the Governor's intended implementation deadline and to eliminate references to MA incentive funds to reflect that the state is not expected to receive MA incentive funds in the 1999-01 biennium.)
