Falconry Permit Fees Rules

Motion:

Move to allow DNR to promulgate rules to establish fees for falconry permits. Specify that revenue from the permit fees would be deposited in the fish and wildlife account of the conservation fund.

In addition, specify that falconry ^{permit} license authorizes a resident of this state to take raptors from the wild, and that a falconry ^{permit} license authorizes a nonresident to take raptors from the wild only if the person has a falconry license or other similar approval from the state, province or country of which he or she is a resident and if the state, province or country allows residents of this state to take raptors from the wild in that state, province or country.

Note:

Under current law, the Department has promulgated rules regarding falconry, including criteria for resident falconry permits and nonresident raptor trapping permits. In addition, the Department currently administers the federal falconry licensing system in the state, and collects the \$25 federal fee for a falconry license. DNR does not have the authority to establish a state fee for falconry permits in rule, however.
