Turkey Hunting License Preference System

Motion:

Move to create a new preference category in the cumulative preference system for turkey hunting licenses for qualified nonresident landowners. Specify that this category would be the fourth preference category, after all other resident applicants and before nonresidents who are not qualified landowners.

Note:

Under current law, there are four categories in the turkey hunting license preference system:

(a) qualified resident landowners; (b) resident applicants who were not issued a permit in the previous season; (c) all other resident applicants; and (d) applicants who are not residents. A qualified landowner is defined as a resident who owns at least 50 acres in one parcel in an established wild turkey hunting zone and who agrees to allow other persons to hunt wild turkeys on that land if they get permission first from the landowner.
