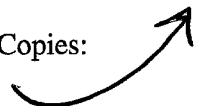

Huber Release for Court Proceedings

Motion:

Move to allow county jail inmates granted Huber release to attend court proceedings.

Note:

This motion would allow county jail inmates granted Huber release to attend court proceedings. Under current law, any person sentenced to a county jail for a crime, nonpayment of a fine or forfeiture, or contempt of court, may be granted the privilege of leaving the jail during necessary and reasonable hours for any of the following purposes: (a) seeking employment or engaging in employment training; (b) working at employment; (c) performing community service work; (d) conducting any self-employed occupation including housekeeping and attending the needs of the person's family; (e) attendance at an educational institution; or (f) medical treatment.
