HEALTH AND FAMILY SERVICES -- MEDICAL ASSISTANCE

HIV/AIDS MA Waiver

Motion:

Move to delete provisions in the bill the limit MA clinical evaluation services that would be available to individuals under an MA waiver for persons with HIV infection that DHFS would be authorized to submit to the federal Department of Health and Human Services (DHHS) under the bill.

---

Note:

Under the bill, DHFS is required to submit a waiver to DHHS that would allow DHFS to provide clinical evaluation services for persons with HIV. These services would be limited to \$500 per person per year for individuals who qualify for MA coverage under the waiver. Under the motion, there would be no limit on total expenditures for individuals who qualify for MA under the terms of the waiver.

In order to obtain federal approval of such a waiver, the expansion of services to this population cannot increase overall MA expenditures. This is sometimes referred to as budget neutrality. The \$500 limit represents the Department's estimate of the total costs that could be supported without exceeding the budget neutrality requirement.
