Subrogation

Motion:

Move to delete provisions in the bill that would allow DHFS to receive the portion of claims resulting from the occurrence of an injury, sickness or death, that represents benefits paid under the medical assistance (MA) program, regardless of whether DHFS joins in prosecuting the claim. In addition, modify provisions contained in the bill that specify that a lien could be placed on any lump sum payment to instead specify that the lien would be on any payment.

Note:

This motion would delete provisions from the bill that appear to be redundant and would allow a lien to be placed on any payment, not just a lump sum payment.
