JFC adopted a massive TANF motion today. I have been asked to submit those portions of the motion that affect the Office of the Governor. The following instructions are based on the adoption of Alternative C5 in Legislative Fiscal Bureau Paper #1104:

- 1. A portion of the funds in s. 20.525(1)(kb) (currently a state ops appropriation under the bill) are intended to fund literacy grants to libraries for literacy services to TANF eligible populations (an aids to individuals and organizations type activity.) We want to create a separate new PR-S annual appropriation under the Office of the Governor for these activities. Could you number it 20.525(1)(kf) to mirror the current 20.525(1)(f) GPR literacy aid appropriation. Perhaps it could also be titled "Literacy improvement aids" and the purpose would be to fund grants to libraries for literacy services [to TANF eligible populations]. The last clause in brackets may not be required, given the way other TANF transfer appropriations have been drafted. All monies received from the DWD block grant would be credited to this appropriation account.
- 2. We also need to reference this new appropriation on p. 443 at line 6.
