World War II Memorial Appropriations

Motion:

Move to include provisions that would add the \$166,100 GPR appropriated to DVA under 1999 Wisconsin Act 2, as well as new PR appropriation for contributions, into the budget bill Chapter 20 schedule and include session law language to affect 1999 Wisconsin Act 2 to prevent the double appropriation of these funds.

Note:

1999 Act 2 created a new GPR appropriation to provide a state contribution to a World War II memorial to be constructed in Washington, D.C. which would match private contributions received for this purpose. Because Act 2 became effective before the effective date of the budget, these new appropriations need to be included in the budget bill. The budget bill will show an increase of \$166,100 GPR, but the net fiscal effect on the general fund will be zero because the \$166,100 GPR under Act 2 will not have to be added in as a miscellaneous legislation cost.
