Move to delete the current law provision that limits members of a local exposition district board who are officers or employes of a private sector entity to two consecutive full terms.

---

Note:

Under current law, board members who are officers or employes of private sector entities serve three-year terms, except for the terms of initial appointments in a newly-created district. The motion would delete the current law provision that limits such board members to two full terms. Currently, this provision would only apply to the Wisconsin Center Board.
