# Analysis by the Legislative Reference Bureau COMMERCE AND ECONOMIC DEVELOPMENT

#### ECONOMIC DEVELOPMENT

Under current law, four appropriations to the department of commerce are for the department's program operations. All four appropriations are annual appropriations, which means that the unencumbered balances in the appropriation accounts lapse to the general fund at the end of each fiscal year. The bill eliminates two of these appropriations and consolidates their purposes into one of the remaining two appropriations so that the department is left with one appropriation for its program operations for the American Indian economic liaison program and one appropriation for its other general program operations.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:


