Summary

This amendment would create an additional (third) circuit court judgeship for Waupaca County. Last year, Waupaca County had a weighted caseload of 1.18 and is ranked number 13. However, of those counties that have greater need, only five have county board resolutions on file that show they both need and want an additional judgeship. Waupaca County is expected to approve its resolution at the June county board meeting. A cost analysis for the county is being developed and the Waupaca County board chair has stated their county is ready to bear any additional costs.

Fiscal Impact

According to the Legislative Fiscal Bureau, the cost associated with creating an additional judgeship would be \$161,800 GPR and \$37,800 PR in 2000 - 01, assuming an August 1, 2000 start date for a new judicial branch. The annual state cost would be \$175,000 GPR and \$3,500 PR.
