## Summary

Choices for Independent Living, Inc., a Wisconsin non-profit corporation with an independent Board of Directors, is a beginning Independent Living Center for southwestern Wisconsin. Working with current facilities like the Hodan Center of Mineral Point, Choices for Independent Living provides independent living services to the growing physically and developmentally disabled population in southwestern Wisconsin.

This amendment designates \$80,000 (GPR) in fiscal year 2000 to Choices for Independent Living to be used for administrative staff and to cover general office start-up costs for operating the center.
