Summary

The Joint Committee on Finance required DHFS to contract with an independent organization to evaluate the Family Care pilots, and required that the evaluation address cost effectiveness, access to services and quality of care. The JFC budget provides \$100,000 annually for the evaluation.

This motion would require the independent organization to include in its evaluation of Family Care an examination of the relative costs of care in an institution relative to care in a community setting. Furthermore, the study would be required to include a breakdown of individual costs.
