1 At the locations indicated, amend the amendment as follows:

2 **1.** Page 66, line 11: delete lines 11 to ~~14~~¹⁵ and substitute:

3 **“20.926 Use of billboards.** (1) No state constitutional officer, other than the
4 governor, may do any of the following:

5 (a) Place his or her name or any picture or other likeness of himself or herself
6 on a billboard or on any other outdoor sign that is used for the purpose of advertising
7 or providing information to the public.

8 (b) Authorize or in any way cause another person to place the constitutional
9 officer’s name or any picture or other likeness of himself or herself on a billboard or
10 on any other outdoor sign that is used for the purpose of advertising or providing
11 information to the public.
