2 1. Page 287, line 14: after that line insert:

3 "SECTION 202h. 20.143 (1) (fg) of the statutes is amended to read:

4 20.143 (1) (fg) *Community-based economic development programs.* The  
5 amounts in the schedule for grants under ss. 560.037 and 560.14 and, for the grant  
6 under 1993 Wisconsin Act 16, section 9115 (1c) and for the grants under 1999  
7 Wisconsin Act .... (this act), section 9110 (7v)."

8 2. Page 1507, line 12: after that line insert:

9 "(7v) GRANTS TO CAP SERVICES, INC. From the appropriation under section  
10 20.143 (1) (fg) of the statutes, as affected by this act, the department of commerce

1 shall make a grant of \$12,500 in each of fiscal years 1999-2000 and 2000-01 to CAP  
2 Services, Inc., for providing technical assistance and management services to small  
3 businesses. The grants under this subsection shall be in addition to any grants  
4 awarded to CAP Services, Inc., under section 560.13 of the statutes, as affected by  
5 this act. Within 6 months after spending the full amount of each grant under this  
6 subsection, CAP Services, Inc., shall submit a report to the department of commerce  
7 detailing how the grant proceeds were used.”.
