**SSI Caretaker Supplement
[Paper #1098]**

Motion:

Move to specify that an individual that is receiving the SSI caretaker supplement remains eligible for the SSI caretaker supplement for any month in which he or she remains eligible for federal or state SSI benefits, regardless of whether they receive an SSI payment in that month.

Note:

Under this motion, an SSI recipient would continue to receive the SSI caretaker supplement for those months in which the individual remains eligible for an SSI payment, but receives a \$0 payment. An individual who is terminated from SSI would continue to be ineligible for the caretaker supplement.

The cost of this provision is expected to be minimal since it would address a need for a small portion of the SSI caretakers that would remain eligible for federal SSI benefits but receive a \$0 payment. Such cases usually involve one-time payment adjustments made by the federal Social Security Administration in the payment of the federal SSI benefit and apply to a small number of the SSI recipients.
