Section 20.505 (8) (g) 1. to 2., 1997 stats., required that on June 30, 1999, a portion of the unencumbered balance in that appropriation account be transferred to the appropriation accounts under section 20.115 (4) (g) and (h), 1997 stats., and lapsed to the general fund. Thus, to accomplish your intent the following transfers must be made:

1. A transfer from the appropriation account under section 20.505 (8) (g) to the lottery fund of an amount equal to the unencumbered balance in the appropriation account under section 20.505 (8) (g), 1997 stats., on June 30, 1999, less the amounts transferred under section 20.505 (8) (g) 1. and 1r., 1997 stats., and lapsed under section 20.505 (8) (g) 2., 1997 stats.

2. Thus, to accomplish your intent the following transfers must be made:

A transfer from the appropriation account under section 20.505 (8) (g) to the lottery fund of an amount equal to the unencumbered balance in the appropriation account under section 20.505 (8) (g), 1997 stats., on June 30, 1999, less the amounts transferred under section 20.505 (8) (g) 1. and 1r., 1997 stats., and lapsed under section 20.505 (8) (g) 2., 1997 stats.

2. A transfer from the general fund to the lottery fund of an amount equal to the sum of the amounts transferred under section 20.505 (8) (g) 1. and 1r., 1997 stats., and lapsed to the general fund under section 20.505 (8) (g) 2., 1997 stats. Note that 1999 Wis. Act 5 repealed section 20.115 (4) (g) and (h), 1997 stats., thus the amounts transferred on June 30, 1999, lapsed to the general fund.
