

**"SECTION 1812s.** 77.51 (9) (e) of the statutes is amended to read:

77.51 (9) (e) ~~An auction which is~~ Auctions that are the sale of personal farm property or household goods and ~~not that are held at regular intervals~~ at a location where the auctioneer or auction company holds fewer than 5 auctions during the year. In this paragraph, with respect to indoor locations, "location" means a building, except that in the case of a shopping center or a shopping mall "location" means a store."
