- 1 At the locations indicated, amend the bill as follows:
- 2 1. Page 4, line 3: delete that line and substitute:
- 3 "(c) Except as provided under par. (dr), an individual who was a part-year
- 4 resident and who filed a 1998 Wisconsin".
- 5 2. Page 4, line 9: delete that line and substitute:
- 6 "(d) Except as provided under par. (dr), an individual who was a part-year
- 7 resident and who did not file a 1998".
- 8 3. Page 4, line 16: before that line insert:
- 9 "(dr) Except as provided under par. (e), a part-year resident who moved to
- 10 another state from this state in 1998 is not eligible to receive a rebate under sub. (2).".
