- 2 **1.** Page 5 line 1: delete the material beginning with that line and ending with
- 3 page 6, line ~~10~~<sup>10</sup> affected by assembly amendment ~~1~~, and substitute:
- 4 “(4) CALCULATION. (a) A claimant who is a resident and married and filed a joint
- 5 1998 Wisconsin income tax return or 1998 homestead credit claim shall be eligible
- 6 for a rebate in one of the following amounts:
- 7 1. If the couple’s 1998 Wisconsin adjusted gross income is not more than
- 8 \$25,000, \$370.
- 9 2. If the couple’s 1998 Wisconsin adjusted gross income is more than \$25,000
- 10 but not more than \$50,000, \$378.
- 11 3. If the couple’s 1998 Wisconsin adjusted gross income is more than \$50,000
- 12 but not more than \$75,000, \$397.

1 4. If the couple's 1998 Wisconsin adjusted gross income is more than \$75,000,  
2 \$420.

3 (b) A claimant who is a resident and single and filed a 1998 Wisconsin income  
4 tax return or 1998 homestead credit claim, or who is a resident and married and filed  
5 a separate 1998 Wisconsin income tax return, or who is a resident and filed a 1998  
6 Wisconsin income tax return as a head of household, shall be eligible for a rebate in  
7 one of the following amounts:

8 1. If the individual's 1998 Wisconsin adjusted gross income is not more than  
9 \$25,000, \$189.

10 2. If the individual's 1998 Wisconsin adjusted gross income is more than  
11 \$25,000 but not more than \$37,500, \$199.

12 3. If the individual's 1998 Wisconsin adjusted gross income is more than  
13 \$37,500, \$210."

14 2. Page 6, line 22: delete "~~\$354~~" and substitute "\$210".
