4 120.13 (37) AWARDING HIGH SCHOOL DIPLOMAS TO VETERANS. Notwithstanding s. 5 118.33 (1), award a high school diploma to a person who is at least 65 years old, 6 attended high school in the school district, left high school before receiving a high 7 school diploma to join the U.S. armed forces during a war period under s. 45.35 (5) 8 (e) and served on active duty under honorable conditions in the U.S. armed forces or 9 in forces incorporated as part of the U.S. armed forces. A school board may award 10 a high school diploma to a person who received a high school equivalency diploma 11 under s. 115.29 (4) after serving on active duty if the person meets the other 12 conditions of this paragraph.
