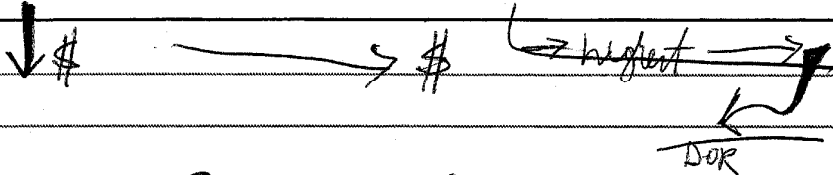

Dear Folks:

Our bill appears to be in jeopardy because Milwaukee and Waukesha counties are objecting to a phrase that WLTA's Bush Nielsen says must be in the bill for their support. "and shall be recorded on the day they are received.." Therefore, I propose to go back to the original language for 59.43(1)(e) except that putting the volume and page on the recording stamp would be deleted - many of us who are scanning don't use a volume and page anymore.

Let me know ASAP if you have any problems with this:

59.43(1)(e) Endorse upon each instrument or writing received by the register for record a certificate of the date and time when it was received, specifying the day, hour and minute of reception, which shall be evidence of such facts.
