6 treatment is provided to the infant or child may report the birth defect in the manner
7 prescribed by the department under sub. (3) (a) 3."

8 4. Page 4, line 22: delete "1. to 3."

9 5. Page 4, line 23: delete "1. to 3." and substitute "or (am)".
