9 to be used solely for display, restoration and preservation purposes.

12 (a) Set up or keep an exempt slot machine on the premises for which the license
13 or permit is issued.

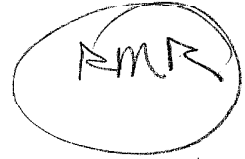
