

Thank you for your call and for your interest in an amendment to AB 432. The following should cover our intent for the amendment (suggested amendment language is noted in bold):

Section 3. 38.24 (4m) of the statutes is created to read:

38.24 (4m) AUDITOR'S FEE EXEMPTION. The Board shall permit a person who is 60 years of age or older to audit a course, **other than a community service program course**, without paying an auditor's fee if the person is a resident of this state, as determined by the board by rule, space is available in the course and the instructor approves.

Or,

Section 3. 38.24 (4m) of the statutes is created to read:

38.24 (4m) AUDITOR'S FEE EXEMPTION. The Board shall permit a person who is 60 years of age or older to audit a course without paying an auditor's fee if the person is a resident of this state, as determined by the board by rule, space is available in the course and the instructor approves. **This section does not apply to community service program courses.**

"Community service program" is defined at § 38.01(4) Wis. Stats. I've also attached a copy of my earlier correspondence of November 30, 1999, to Representative Huebsch on the bill.
