

Page 29, line 18: after "practicable." insert "The explanatory statement included in the type C notice shall indicate that an affirmative vote on the first question will authorize the funding of debt service costs on bonds not exceeding \$160,000,000 in principal amount, exclusive of bonds issued for the purposes specified in s. 229.829[✓] (4), the proceeds of which may be used for purposes related to football stadium facilities, including the maintenance, operating and administrative costs specified in s. 229.825[✓] (2), and shall set forth in each instance the specific maximum dollar amounts and purposes for which the bond proceeds may be used."[✓]
