### *Analysis by the Legislative Reference Bureau*

In 1999 Wisconsin Act 4, the public debt limit for housing state departments and agencies was increased from \$259,727,600 to \$319,227,600. In 1999 Wisconsin Act 9, the public debt limit for housing state departments and agencies was increased from \$259,727,600 to \$328,146,600. The increase in the debt limit in 1999 Wisconsin Act 9 did not take into account the increase in 1999 Wisconsin Act 4. This bill reconciles the two acts by setting the limit at \$387,646,600, thereby giving effect to the increases provided in both acts.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

3 **SECTION 1.** 20.866 (2) (y) of the statutes, as affected by 1999 Wisconsin Acts 4  
4 and 9, is repealed and recreated to read:  
5 20.866 (2) (y) *Building commission; housing state departments and agencies.*  
6 From the capital improvement fund, a sum sufficient to the building commission for
