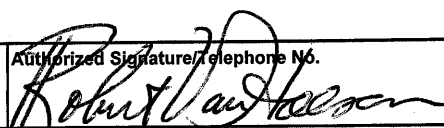

SUBJECT: WAGE INCREASES IN 1999-2001 CONTRACT AGREEMENT

WISCONSIN STATE PUBLIC DEFENDERS ASSOCIATION

A. NEGOTIATED FISCAL YEAR INCREASES:

- 1. FY 99-00: Base building adjustment of \$1.55 per hour, subject to the 1999-2000 pay range maximum.
- FY 00-01: (1) Effective July 2, 2000, \$0.166 per hour general wage adjustment, subject to the 2000-2001 pay range maximum.
- (2) Effective July 2, 2000, merit generation of \$1.70 per hour. Employees can grieve if 50% of the merit generation is not received, subject to the 2000-2001 pay range maximum.
- (3) Effective October 8, 2000, \$0.246 per hour general wage adjustment, subject to the 2000-2001 pay range maximum.
