We have a Joint Hearing with the Senate Agriculture, Environmental Resources and Campaign Finance Reform Committee on November 18 at 12:30 p.m. This joint hearing will consist of a two-hour briefing from the Department of Agriculture regarding the situation with the Animal Health Laboratory.

We then have the option of hearing testimony on Assembly Bill 483 and taking executive action on Assembly Bill 506. This would most likely extend our meeting another two hours minimum. We would then have the current business before the Committee completed and would not need to meet in December unless we receive additional legislation. If the majority of the members choose to hold two meetings, the December meeting would be on Thursday, December 2, 1999 at 9:00 a.m.
