

Dear Chair Ladwig:

On behalf of our 83 food pantries and 40,000 individuals per month that we serve through these pantries, Hunger Task Force of Milwaukee respectfully requests that the Assembly Committee on Children and Families schedule Senate Bill 37 (SB 37).

SB 37 requires the Wisconsin Department of Workforce Development (DWD) to request a waiver from the U.S. Department of Agriculture which removes the requirement for individuals residing in an area with more than 10% unemployment or insufficient jobs to participate in the Food Stamp Employment and Training Program.

HTFM supports SB 37 because it would allow many individuals who, because of circumstances out of their control, have been ineligible to participate in the Food Stamp Program. These individuals are from rural and urban communities in Wisconsin, and they all have a right to participate in this program. No individual, particularly those who have low incomes, should be arbitrarily cut off from receiving nutritious food.

This bill would require the DWD to help these affected individuals by requesting a waiver on their behalf. SB 37 passed the State Senate on January 25, 2000 and includes sponsors from both parties. For these reasons, this bill warrants a public hearing by your committee.



Dear Chair Ladwig:

On behalf of the Wisconsin Grocers Association representing more than 1,500 independent grocers, retail grocery chain stores, warehouses and distributors, convenience stores, food brokers, suppliers and wholesalers, we respectfully request the Assembly Committee on Children & Families to schedule Senate Bill 37 (SB 37).

SB 37 requires the Wisconsin Department of Workforce Development to request a waiver from the U.S. Department of Agriculture which removes the requirement for individuals residing in an area with more than 10% unemployment or insufficient jobs to participate in the food stamp employment and training program.

The reason grocers support this legislation is simple: we believe in providing food for every individual. If an individual is unable to purchase food for any reason, whether it is a physical or financial limitation, we support the government stepping in to fill in the gap.

SB 37 does just that. It fills in the gap for individuals ineligible to participate in the food stamp program due to circumstances out of their control by requiring Wisconsin's DWD to remedy the situation by requesting a waiver on behalf of these individuals.

This bill has bi-partisan support from both houses and was passed by the state senate on January 25, 2000. For these reasons alone, this legislation warrants a fair hearing by your committee.
