Dear Senator Breske: *Roger*

I would like to bring your attention to three bills, Assembly Bill 57, Assembly Bill 136 and Assembly Bill 137, which have been referred to the Senate Insurance, Tourism, Transportation and Corrections Committee.

As you know, all three of these bills were introduced at the request of the Department of the Transportation. AB 57 changes the effective date of the administrative disqualification period for commercial drivers and updates the state's definition of "transporting hazardous materials." AB 136 transfers appeals related to two DOT programs from the Division of Hearings and Appeals to the Tax Appeals Commission. AB 137 repeals outdated references to liens on motor vehicles that were issued prior to June 1, 1966.

During the public hearings on these bills, no one testified or registered in opposition. All of them were unanimously approved by the Assembly Transportation Committee and passed the Assembly on voice votes. Thus, I am respectfully requesting that AB 57, AB 136 and AB 137 be scheduled for consideration by your committee. If you have questions regarding any of these bills, please let me know.

RE: Transportation bills

Per our recent phone conversation, listed below are the transportation-related bills we have introduced together that are waiting to be scheduled for action by the Senate. I would appreciate anything you can do to move these bills forward. Thank you.

Brandemuehl/Breske bills:

1. AB 54, relating to issuing dealer registration plates to motor vehicle salvage pools.
2. AB 55, relating to misuse of distinctive dealer registration plate by a motor vehicle dealer, distributor, transporter or manufacturer.
3. AB 56, relating to motor carriers and the single-state insurance registration system.
4. AB 57, relating to eligibility to operate commercial motor vehicles and the transport of hazardous materials.
5. AB 58, relating to administrative action against motor vehicle auction dealer's licenses.
6. AB 59, relating to motor vehicle registration expiration dates.
7. AB 136, relating to transferring appeals of certain determinations of the department of transportation from the division of hearing and appeals to the tax appeals commission.
8. AB 137, relating to older security interests in motor vehicles.
9. AB 206, relating to creating a permit authorizing the operation upon a highway of a specialized hauling rig that exceeds statutory size and weight limits.
