

FINDING OF EMERGENCY

The Higher Educational Aids Board (HEAB) finds that an emergency exists and that the attached rule is necessary for the immediate preservation of the public peace, health, safety or welfare. A statement of the facts constituting the emergency is:

The 1989 Wisconsin Act 31 created s. 39.40, Stats., which provides for loans to minority students enrolled in programs of study leading to licensure as a teacher. The Wisconsin Higher Educational Aids Board (HEAB) administers this loan program under s. 39.40 and under ch. HEA 11. Current rules require that a student be enrolled full time and show financial need to be considered for participation in the Minority Teacher Loan Program. Students who did not enroll full time and did not show financial need were allowed to participate in the program in the past when part of the program was administered by another administrative body. These students are enrolled in teacher education programs that train teachers specifically for the school districts named in the statutes that outline the intent of the Minority Teacher Loan Program. Unless the Board changes its rules, many participating students will lose their eligibility in the program. This will cause a hardship to those students who relied on the interpretation of the prior system administration. Revising the rules would allow students who participated in the program in the past to continue to participate. The proposed revision will not affect expenditures of State funds for the Minority Teacher Loan Program.

Statutory Authority:

Section 39.28 (1), Stat., as created by 1971 c. 125, and section 227.11 (2), Stats.

Section HEA 11.03 is amended to read:

Section 1. Section HEA 11.03 (3) is amended to read:

(3) The borrower shall be enrolled <u>full time</u> at least half time in an eligible institution in the junior or senior year of a bachelor degree program majoring in education.

Section 2. Section HEA 11.03 (5) is created to read:

(5) The borrower shall not be required to show financial need.

1999-2000 ACADEMIC EXCELLENCE SCHOLARSHIP PROGRAM Annual Status Report

1999-2000 was the fourth year that the \$2,250 cap was placed on the Academic Excellence Scholarship (AES) freshmen recipients. There were 736 freshmen scholars under this cap requirement utilizing \$802,587 of the program's funds. In 1998-1999, 704 freshmen scholars required \$784,054 to fund their scholarships. The award cap was initiated to control spending. Now that all four classes, freshmen through seniors, have a tuition cap tied to their scholarship; spending in this program has stabilized. Cost per freshman was \$1,114 in 1998-1999. In 1999-2000, cost per freshman was \$1,090. We must continue to give attention to any possible trends that reflect that the cap is discouraging students from using the scholarship.

Criteria described in the statute for alternate students was modified, effective for the 2000-2001 academic year. Previously, a student could be considered an alternate only if he or she had the same cumulative grade point average (GPA) as the student(s) designated as recipients of the scholarship. The modification to the statute allows for the naming of a student with the next highest cumulative GPA as an alternate, if the high school uses a weighted grading system. As of July 15, 2000 there are nine more scholars named as alternates for the 2000-2001 academic year than there were at the end of the 1999-2000 academic year.

Seven tables are attached showing final figures for 1999-2000 along with preliminary data for 2000-2001.

- Tables I, II, III present enrollment information by sector (University of Wisconsin, Wisconsin Technical College, and Wisconsin Independent Colleges and Universities.) These figures represent the students who received AES Program funds.
- Tables IV and V present financial need related information by sector. The average contribution and adjusted gross income (AGI) figures are for AES Program recipients who also received other State of Wisconsin funded financial assistance (Wisconsin Higher Education Grant, Wisconsin Tuition Grant, Talent Incentive Program Grant, and Wisconsin Indian Grant.) The figures in the HEAB AES Amount column are the scholarship funds administered by HEAB. This amount is matched by the school that the student attends in order to fully fund the scholarship award.
- Table VI presents general information such as the number of scholars using their award to attend a Wisconsin college or university.
- Table VII gives preliminary information for 2000-01 freshmen.
