American Indian Arts (see Tribal Gaming Revenue Allocations -- Paper #159)

ARTS BOARD

Cultural Diversity Initiative

Motion:

Move to provide \$125,000 GPR annually in a new, annual appropriation within the Arts Board to establish a cultural diversity initiative under which grants would be provided to arts organizations for which a majority of the organization's board members ~~and audiences~~ would be people of color. Specify that for the purposes of the initiative, a person of color would have to be one of the following: (a) "African American," defined as a person whose ancestors originated in any of the black racial groups of Africa; (b) "American Indian," defined as a person who is enrolled as a member of a federally recognized American Indian tribe or band or who possesses documentation of at least one-fourth American Indian ancestry or documentation of tribal recognition as an American Indian; (c) "Asian," defined as a person whose ancestors originated in Asia south and southeast of the Himalayas and west of Wallace's Line in Malay Archipelago; or (d) "Hispanic," defined as a person of any race whose ancestors originated in Mexico, Puerto Rico, Cuba, Central America or South America whose culture of origin is Spanish. Specify that a grantee would have to provide at least 50% of the estimated total cost of the project, either in the form of moneys or in-kind contributions.

Note:

This motion would provide \$125,000 GPR annually in a new, annual appropriation for a new grant program under which grants would be awarded to arts organizations for which a majority of board members ~~and audiences~~ are people of color. A grant recipient would have to provide a match, either in cash or in-kind contributions, equal to at least 50% of the estimated total cost of the project.

Move to provide \$100,000 GPR in each year of the 1999-01 biennium to increase funding for the state aid for the arts program. Specify that the additional monies would be provided on a one-time basis.

Note:

This motion would increase funding for the Arts Board's state aid for the arts program by \$100,000 GPR annually. The additional funds would be provided in the 1999-01 biennium only. After 2000-01, the amount appropriated for the program would be restored to the 1998-99 adjusted base level.
