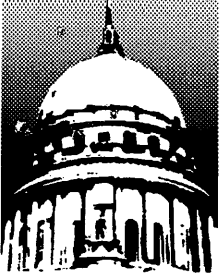

SUBJECT: Testimony on Assembly Bill 351

On December 8th in Spooner Wisconsin, many representatives, agency personnel, and hunters testified on behalf of AB351 before the Assembly Committee on Natural Resources. Close to 600 individuals registered in favor of AB 351.

Hunters testified that the current law places an unrealistic burden on those who hunt with dogs or train dogs for hunting purposes. While hunting or, especially while training young hunting dogs, it is difficult to completely prevent a dog from temporarily ranging too far.

Hunters also spoke on the fact that people who are opposed to hunting with dogs have abused the current law when they have picked up dogs that were being used for hunting and claimed that the owner should be fined for letting the dogs run at large. AB 351 would prevent people from making that claim if the dogs were actively engaged in a legal hunting or a hunting-dog training activity on public lands or land that the hunter has permission to use during the legal season for hunting or training.

There were those who testified against AB351 feeling that hunting in any form should be abolished. For many families, hunting with dogs, and training hunting dogs is a family activity which includes parents and children working together. AB351 would help to preserve a traditional form of hunting.

This is not a bill which will simply let dogs roam anywhere freely. The bill as amended by the Assembly Committee on Natural Resources places specific requirements on where the dog may be released. To protect landowners rights against trespass, the dog may only roam on public land which is open to hunting, or land which the owner has given permission for use in hunting or training.

AB 351 is a pro-hunting bill. It is a bill which has broad bipartisan support. AB 351 was reported out of the Natural Resources committee on an 11-1 vote, and on February 8th AB 351 passed on the floor of the Assembly with a vote of 82-14. This bill is viewed by many hunters as being pro-hunter in a social climate where hunting is tolerated less and less.
