Dear Mr. Chairman,

My name is Claudia Cody and I am an inmate at the Rober E. Ellsworth Correctional Center in Union Grove, Wi.. Enclosed is a letter to the ACLU in Milwaukee concerning the present conditions of the women's correctional facilities that greatly contribute to the risk of health and safety for all who reside and/or work here. In addition to the concerns listed therein, I understand you will be meeting in March to review the current health care practices of the women's prison and I would like to ask that your committee look into all aspects of our confinement.

I was housed at the Taycheedah Correctional Facility for over a year in which time, I suffered from an abscessed tooth to which no treatment was offered. I was placed on antibiotics for over a year and due to the infection having spread, several more abscesses occurred and I developed a systemic infection that was not addressed until my transfer to the Robert E. Ellsworth Facility. In my time at TCI, I witnessed several occasions where inmates were forced to walk on or suffer with, broken limbs because HSU didn't feel it was an "emergency". Some of the breaks were so obvious, even a lay person could tell it was broken and needed immediate medical attention.

The HSU staff at TCI was notorious for ignoring the requests of the inmates as far as medical attention was concerned. It didn't matter whether a person had a known and previous episode of an asthma attack, seizure, or other physical dysfunction, and when in the mists of a present attack, HSU would be reluctant to come to the building, often times having that person <u>WALK</u> down to HSU or, HSU refusing to see them at all. The HSU staff had an attitude of indifference towards inmates. This encompassed the entire population; all inmates were "liars", "attention seekers", or "fakers".

With my own experience as well as having witnessed several episodes of indifference by HSU to other inmates, is rempered. The hostile attitude in which we are spoken to, is haven. I myself, having been told by them that I was "full of shit" when I told them I was being denied necessary treatment and that the infection was spreading. I know of inmates who had been taken out of the institution to receive emergency care at a hospital only to have those physician orders completely ignored upon the inmates return to the correctional facility.

The procedure to see HSU is to "drop them a slip". This is a blue medical slip in which the inmate describes her problem or medical dilemma and they then place this "slip" in the appropriate medical mailbox. The HSU staff then determine whether or not it is an emergency which nine times out of ten, it is not. However, those "slips" still raise valid ailments and difficulties which HSU will not address for several days, or weeks, and on numerous occasions, forget about them all together resulting in the inmate having to go through the whole process all over again and further waiting and denial of care occurs. The pain we experience from broken bones, abscess, deep cuts, falls, injuries from fights, etc., are legitimate, yet HSU is slow to accommodate your needs. They often times fail to conduct tests or x-rays the inmates symptoms call for and do not staff the facility with qualified, competent personnel.

In comparison to the care afforded to inmates at TCI, the Robert E. Ellsworth

not the fault of the current medical staff. They cannot possibly be expected to stay affront of the demanding medical problems women suffer from at the rate of the growing population. Nurse Hammes is being "worked to death" here. Dr. Muldron isn't too far behind her. Being over-worked and tired has lead to deficiencies in the health care provided to inmates at REECC. I am not trying to "slam" the care here. I am saying though, the state needs to employ medical personnel sufficient in number to reach the needs of the growing population and to get updated equipment for more "in-house" treatment and diagnosis rather than having to call an ambulance or be taken to the ER for stitches or minor cuts/injuries which cost the taxpayers even more than having had the right equipment in the first place.

I have enclosed several ICI's dealing with the conditions of our confinement. I strongly implore you to look closely at the "totality of the circumstances" that lead to further illness, injury and safety issues. I pray that something can be done to benefit both the inmates and the public as well.

This ICI is in regard to the raw sewage that backs up into our kitchen on a frequent basis. This is the third such ICI on the matter to which none of the previous ICI's were properly delt with, acknowledged in the time prescribed by Admin. Code CHAPTER DOC 310, or given proper complaint numbers.

A sanitary environment is a basic human need that a penal institution must provide for all inmates. The Eighth Amendment is violated by seriously defective plumbing <u>JACKSON v. DUCKWORTH</u>, 955 F. 2d 21, 22 (7th Cir. 1992). This back-up of raw sewage into the REECC kitchen poses a serious risk to the inmates and officers health. Prison food must be prepared and served under conditions which do not present an immediate danger to the health and well being of those who consume it. Having raw sewage containing feces, soiled tampons, toilet tissue, urine, and other such debri back up into this institutions only food service kitchen, creates health hazards in that preparation(as well as to those who must clean up the waste)which is sufficiently gross. Under these conditions, prisoners need not prove that serious food-borne illness has already occurred; the existence of the risk is enough to violate the Constitution and I am tired of being exposed to that risk day after day. This serves as Notice to REECC and the DOC that injunctive relief and court intervention will be commenced for the failure to remedy this situation in a timely manner. Sec. 893.82 Wis stats., does not apply to a prisoner seeking injunctive relief if there is a risk to the health and safety of that

Dear Senator Judy Robson,

After reading the articles in the Milwaukee Journal Sentinel regarding the prison system in Wisconsin, I was outraged. Our son almost died at the hands of the prison system, at which time I wrote the Governor and received no response. Please read on and so you can give us some help before it is too late.

I feel you need background information to have a clearer understanding to this grave situation. At the age of 17 our son suffered a severe asthma attack that caused severe brain damage, it left him disabled without a short term memory. After intense training at the Mary Brigh Center, associated with the Mayo Clinic, Michael learned to live independently with some help from his family.

In 1997 on his way to work he suffered a brain injury related seizure, and his truck hit the automobile ahead of him which resulted in the death of three people. After many court appearances, an inadequate lawyer, and a judge that wanted to use Michael as an example sentenced him to 10 years in prison. It was an unjust plea agreement, the District Attorney was asking for 6 years. Michael has no prior convictions.

Michael was sent immediately after court to the Outagamie County Jail where the first of the abuse started. Michael suffered an asthma attack there and pounded on the cell door, after some intense screaming from his fellow inmate a guard came running and got a nurse with Michael's inhaler. I questioned the nurse the following day and she said Michael had his inhaler at all times, the start of many lies, if Michael had his inhaler he would not have pounded on the cell door.

After 8 days in the County jail he was sent to Dodge Correctional, mind you he was wearing the same underwear as when he went in. There our disabled son would spend four long months on A&E without a T.V. or radio, the only thing in his cell was a tablet of paper and pen. It took a month for him to get his prescription glasses. He went outside once in those four months. He could not find his way back to his cell, due to his severe short term memory loss, after that one venture outside he had to stay in his cell. The inmates and guards had taunted him, calling him a retard and a nark.

I wrote the Commissioner of prisons, Mr.Sullivan, asking not to send Michael to Portage. Again, my pleas were not heard and Michael was sent to Portage on September 24 1998. Every chance our family could get to visit Michael we did, this included every Wednesday, Sunday, and sometimes on Fridays. Michael finally received the radio we sent him on November 4 and his T.V. sometime after that. Once again, it took a month to get his glasses. Michael's social worker, Mark Kohn was the most vile person I have encountered since Dodge. The social worker at Dodge told me to stop coddling my son and to leave her alone.

December 6 1998 the more severe abuse begins. On December 6 Michael's father, myself, and a friend went on our usual Sunday visit, what we witnessed on that day should never occur in our country. Michael came out to the visitor's room a total zombie, he couldn't talk and he would look at us with a blank stare. He only shook his head back and fourth and would laugh inappropriately. I went to one of the three guards and asked him to call medical personnel because there was something seriously wrong with our son, I felt he had a nervous breakdown, the guard was also concerned. After the guard had called Michael's unit their response was to send him back to his unit for more medication. I explained he does not need more medication he needs a doctor, the guard told us it takes an act of God to get a doctor on a weekend. We had no choice but to leave our disabled son in this god awful state of mind. Michael could never defend himself physically or mentally due to his memory problem.

I called Mark Kohn on December 7 to tell him about the visit on Sunday and ask how Michael was doing. The response I got from Mark was "Michael's doing all of this for attention" and he would not bother anyone on his unit, to leave matters up to him. December 9 Michael's sisters went to visit him and the guards told them he was in lock up because of an indecent incident, Michael would never do anything of such a nature. December 13 Michael's father and I went for our visit. Upon arriving Officer Schneider came to talk with us, he told us Michael had broken off his radio antenna and carved his wrist, he told us it was a cry for

help. Yes it sure was, as we later learned from Michael. Officer Schneider said he was in the medical unit under close supervision.

December 16 Michael was transported from Portage to Wisconsin Resource Center. The personnel at W.R.C. were very kind. Michael was not eating, his weight dropped from 187lbs. to 129lbs., and he had extreme paranoia according to the nurse, Dan Lelman They had to force feed him through the nose, at one point Michael collapsed from malnutrition and sent to Mercy Medical Hospital in Oshkosh. We tried to visit Michael the first chance they would let us but he refused the visits on December 25 and 27 of 1998.

January 3 our first visit with Michael at WRC, this is a visit no one would believe, but there has to be video tape of this visit and the following ones. If you were to view these tapes our once happy, physically healthy 30 year old would show a different person. The entire left side of his face showed yellow makings from an old huge bruise, one tooth cracked off, and stitches in the top of his head. His actions and words were bizarre to say the least. He would curl up in a fetal position against the wall in the visitor's room. We had thought this is not our son, what have they done to him? I called Dan on January 8 telling him of the stitches and the old bruise on Michael's face. I was told nothing was documented from Portage and if he had stitches they would remove them. That in itself was odd, how would they not notice there had been stitches in his head it was one of the first things we had noticed.

January 10 Michael was paranoid, and the stitches had been removed. Michael talked of the voices that told him what to do. At one time the voices told him not to stand up for count and he was sent to segregation for 8 days, all there was in the cell was a mattress on a floor, this is humane? In the months of January and February we would visit every Wednesday, Friday, and Sunday and most of them Michael would refuse, why? We didn't know.

February 19 1999 I went with two friends to visit Michel and that's when he revealed the shocking news to us. At Portage they had attempted to rape him, that's how he received the blow to the head and the bruised face. He whispered all of this information for fear of his life, once again. Michael went into the system with beautiful white teeth, now there is a tooth that is cracked off, and his gum lines are receding because they won't allow inmates to have dental floss.

As of this date Michael is doing better at W.R.C. where there are nurses that administer the medication properly, and the protection for each inmate seems to be better. Michael's nurse, Dan, has spoken with me on numerous occasions and he assured me of Michael's safety.

Michael still keeps to himself in his cell for personal safety reasons, except for 2 hours per day working in laundry. If they would send Michael out to a regular prison amongst other inmates it surely would be a death sentence for Michael. At Dodge and Portage Correctional the guards hand out the medications from blister packs (7 per pack) they have no idea what the medications are for.

If anything like this would have happened outside the prison walls someone would have to be held accountable for their abuse. To ask for an outside investigation in our prison system most who work there would lie to cover up the abuse and wrongdoing to the inmates. I have tried everything to get an honest answer regarding our son's abuse and received none. I have stopped investigating for fear of Michael's life.

If this were your child on the receiving end of this kind of abuse what would you do? Please help Michael and other inmates faced with the abuse that occurs daily within our prison system. You have the power and resources to put an end to the atrocities in our prison system.

Dear Ms Robson:

Thank you for your expressed outrage at the death of Taycheedah inmate Michelle Greer. It should not happen. It seems as if most response-action is taken on the basis that inmate has lied or exaggerated their condition and therefore they do the least for them.

As a matter of introduction, I am a member of Prison Fellowship and conduct a support group in Waukesha for inmate's families. I'm also a tutor at the Waukesha County Jail. As a member of St Vincent DePaul Dismas jail ministry, I visit juveniles in detention once a week. I have been corresponding with 30 inmates for about 4 years. We have a parolee living with us and mentor two others. I visit inmates in several prisons as well. I know what the DOC does to these inmates.

Taycheedah is not the only place where death is waiting to happen. Enclosed is a copy of a letter from a man sent to Sayre OK with a history of depression. He tells of a man with cancer getting morphine for pain. That man should be in Wisconsin so his family can see him regularly.

I know from a group called, "Walk of Faith" that medical records are withheld and don't follow inmates out of state. CCA owned and operated private prisons don't want the expense of medication. The DOC doesn't want the expense either so they continue to send bi-polar and schizophrenic patient out of state in breach of the out of State contract. My friend is being shipped to Mason TN. He is bipolar and has high blood pressure. The bipolar medication has made great difference in his life. I fear that he will not get the needed medication in that private prison. They will not send the medication with him.

A person I have written to for several years had his hand slammed in the cell door at Waupun and no medical examination, x-rays, or pain medication was given for 12 hours. There is supposed to be 24-hour emergency care. But once again lack of treatment is based on the premise that the inmate wants attention or is lying and exaggerating.

There is retaliation against the inmate when family members intervene about lack of treatment.

Also doctors have been relegated to the institutions because they have been banned from practice in public hospitals as in Waupun.

Treatment is punitive and inappropriate. Guards give out psychotropic medications. Can they tell one type of medication from the other? Do they ever get nixed up?

Taycheedah may be the tip the iceberg. All prison medical practices should be audited. Death can happen at anytime by neglect or inappropriate medication.

Dear Joan

Thank-You for your letter dated January 23, 2000, and also for the puzzles. I believe I've read your letter over three times. I've also shared it's contents with my neighbors. I would like to follow your letter to comment on some important issues.

When I entered Waupun in 1996, accounting was deducting 75% of all money sent in or earned. The Judges' orders stated 15% of all money <u>earned</u>!! After taking a few hundred, I threatened to write Judge Timothy Dugan (sentencing Judge). A Mrs. Wallintin (Accounting) wrote saying they would reduce the percentage immediately. I only owed \$525.00, and they had already taken \$380.00 in five months. I have a 20 year sentence!! Mrs. Wallentin said, "we can take 100% percent if needed, the state is entitled to their money!" The last \$135.00 came off at 15%.

Joan, I have <u>not</u> and <u>will not</u> receive my medications. I am having problems <u>seeing double</u>, possibly a medication side-effect??? This has been going on for <u>over two months</u>. The psychiatrist has now taken me off of Doxepin, Trazodone, my bi-polar medication-Lithium, and now my cholesterol medication-Les-chol. None of this has helped and I'm suffering with extreme anxiety, little or no sleep, and weird mood swings! At my last appointment, the doctor (psychiatrist) said he was lost & guessing about my vision problem. I've seen the eye doctor, with same opinion, lost or guessing.

The CCA & Wisconsin contract states, "no inmate with a serious medical problem will be transferred to an out-of-state facility!!" My problems are minimal, one inmate is being pushed around in his wheel chair while wearing a neck brace. Another inmate on my unit has cancer and receives injections of morphine & other pain medications. They don't belong here!! Many inmates are not receiving medications or adequate care. I've read the Doc guidelines which state, a psychologist is a state licensed "psychologist." I have been receiving counseling one hour per week for 12 weeks from a medical employee without a title or degree in psych!! She (mrs. Baker) is careful not to seriously advise. Her sessions have been for my depression, we've seen no progress!

I have written the Wisconsin out-of-state transfer people, Sec. of DOC, Jon Litscher and recently, a Dr.Ted Garlewski Chief Psychologist of Wisconsin DOC., receiving no help. I feel my depression needs are as real as the next mans' drug treatment or anger management for others. The Judge recognized my mental health issues and stated same in transcripts. Maybe a letter to the judge or a lawsuit would help ?

Concerning Mr. John Tiggs & Mr. Daron Walker, I don't know them. I am familiar with their AT&T duct-work intercom and the fishing system! I wish them luck !

Joan, you mentioned Harold Eisenberg; can you possibly help with addresses ? We have an old copy of the Milwaukee Yellow pages; no white pages. I will invest in a Wisconsin Blue Book, everyone's listed in there.

I've read some interesting Journal-Sentinel articles on out-of-state prisons, security at Whiteville, Tn. & here. I would appreciate addresses for Sen. Gwendolynne Moore, Gerald Kleczka, Ron Kind, Tammy Baldwin and any others you can think of ??

When I read about possible creation of a residential housing program for pedophiles', I get angry. I cannot get a transfer to any adequate treatment facility for depression. I'm told that a good program exists at Winnebago Resource Ctr..

I've read about Wisconsin Officials and Wahington Officials being stockholders of CCA stock, longer sentences and more outof-state transfers will raise their stocks.... Conflict of interest !!!

As you can see, I just received my order of typewriter ribbons. After re-reading this, I see many mistakes, please bear with me !

The out-of-state transfer people (Janice Mink-Wi.DOC) and others are closing their eyes to many problems. My complaints about our racial fight and safety was ignored by Jan Mink on her January visit..

RE: Death of Michelle Greer....

Dear Madam:

This letter is in regards to the death of Michelle Greer on 2-2-00 at the Taycheedah Prison for women. I am aware of too many similar incidences of this type of care, including my own, so this is far from an isolated case. I will make reference to only a few such cases, because I don't have the names or enough information to elaborate on the many cases of medical abuse I'm aware of during my 13 years in prison. I will describe a similar situation that almost resulted in my death, plus other episodes of neglectful or contemptuous standards of health care, which reflect prison health care as a whole. It is a trauma in itself to be aware of all these abuses, and to be locked in a room when something happens knowing help is a long way off if it comes. My concern is not only for other inmates and myself, but also for a society that would allow this standard of medical care or neglect. Your legal system fraudulently put me in prison for life, but I still want to have respect for the Humanity that I'm part of, so I don't want to believe that these abuses are your real intentions.

YOu take away our legal rights and make it almost impossible to redress abuses by taking away funding from the Public Defenders Office previously used to help inmates, and you make justice unaffordable for us, you frustrate us to no end and then persecute those who turn rebellious out of disrespect to your ways by subjecting them to an illegal and improperly applied disciplinary system, you feed us inadequate food and deprive us of certain foods and health items, you make us pay for some items and health care the Department of Corrections is required by law to provide, you take away our right to care for ourselves where we can, you confine large amounts of inmates in small areas like the new barracks Styled living quarters, which are nothing but cesspools for disease, you force two inmates into a small room to wallow in each others bodily functions, your bathroom facilities are unclean and inadequate for the overcrowding conditions, which expose inmates and staff through this close mingling to serious contagious diseases, you provide us with doctors who have lost their licenses, or who are inept and biased toward inmates,

and nurses with a lackadaisical or contemptuous attitude towards the needs of inmates, you make lawyers fearful of helping inmates with viable health claims, and then when something like the death of MIchelle Greer hits the newspapers your suddenly appalled that this vile treatment occurred.

What gives the DOC the right to deprive us of health care, and to make us pay for most of our needs in over-the-counter meds by forcing us to buy them through the canteen. WHen the legislatures wrote up the co-payment plan for inmates it was directed at inmates who are wage earners, not those who barely get \$40 a month on average. Taycheedah is anything like The Fox Lake Corr. Inst Health care system then Michelle Greer had to by her asthma medication through the canteen, which has a propensity to run out of these necessities, or if lucky she had to continually beg for this medication. Many times they will deny your needs and tell you to submit a money transmittal, so you can be seen by the health staff and have you needs reevaluated, and then they tell you you no longer have the problem. I would gladly pay for as much of my health care needs as possible if thats what I got. I've payed for \$14 worth of fruit each month for the past 7 years, because food service doesn't provide it. If the DOC can't afford to provide me with the correct standard of health care why can't I obtain it on my own, or in some cases I can get care from the Veterans Administration, but it seems the Health care people would rather see me suffer. Why also is it that the DOC can stop an outside investigation of its activities, when they have no power to make any such rule or law. Chapter 227 only allows them to make rules and laws through interpretations of laws made by the legislatures.

My records will show that I came into the prison system in extremely good condition, and that most of my life I was a exercise and nutrition nut, but now after 13 years of prison at the age of 57 I'm lucky I can still walk for a short period, and this is at the expense not getting treatment for certain conditions I had before incarceration, which I explain later. If you want to see 13 years of medical abuse I'll provide my entire record. I have filed many complaints and health requests in the past 13 years. I have written letters concerning some of these problems to the ACLU, but they claim they can't afford to help. They recently investigated some of the health care problems inmates are having, but the last I heard they couldn't get enough funding to take

legal action. I had provided them with close to a hundred pages of my medical problems. I have filed many ICI's and one ICI under DOC 310 for civil rights to no avail. I have filed at least 6 Notices of Injury to the Attorney Generals office, and many claims to the Department of Regulation and Licensing, who always have the same caned response. I I filed a claim with the Civil Rights Office in Illinois, and they sent it to Mr. John Wodatch, Chief Disability Rights Section Civil Rights Division, U.S. Department of Justice in Washington, D.C. WERE IT PRESENTL SITS. I've written letters to various legislators, and to Wisconsin C.U.R.E., BUt none of these places respond. It should be clear that this is the quality of care the DOC wants.

Near Death Experience

In Sept. 1998 at Fox Lake Correctional Inst. while being forced to live in their barracks for six months I developed a sore throat and loss of my voice. I was seen by a nurse, and had a throat culture taken that supposedly turned out negative. No treatment was provided despite that similar problems were breaking out throughout the Inst.. Over the next few months this condition got worse, and I was unable to sleep at night, because I would continually awaken from choking or completely unable to breath. I have attached a notice of Injury I filed with the Attorney Generals Office, which explains the events in chronological order. On numerous occasions I awoke unable to breath, and through desperate attempts to breath I must have damaged my throat or something, because I would then be coughing up blood. It took a long time for this to heal , and it still feels like something is wrong when my neck is in a certain position. I never received any care for this problem, and still don't know what it was. I recently read about a condition that had similar symptoms, and I believe it was called croup. I talked with many staff people where I worked to get help, but it still took a long time to get an appointment with the doctor, who completely ignored it. Most staff were helpful, but one casually told me to have another inmate stick a tube down my throat if I couldn't breath. THIS WAS THE MOST FRIGHTENING thing I ever went through. I filed a complaint through the ICI system, a notice of injury, a complaint with the Dept. of Regulation and Licensing, and letters to health personnel to no avail.

When I came into prison I had two related conditions from a car accident, which gave me a partial disability, and I was being treated for both of these conditions on the outside. THe DOC Health DEpartment was aware of these conditions, and had them evaluated, but they reduced or changed the original treatment, and in some cases they provided no treatment. I have repeatedly over 13 years begged for basic forms of care, but can't even get a decent mattress for this condition, which consists of a disability to the neck and back. This condition has worsened over the years from lack of care, and now adversely effects activities throughout the day. This condition led to a TMJ condition, and I had a lot of orthodontic work in progress on my teeth at the time of incarceration, which was stopped and changed by DOC. This has caused more TMJ symptoms, and damage to all my teeth. This matter as previously stated is with the DEpartment of Justice, and they have over a hundred pages of records, including all the complaints and Notices of Injury I filed over the years. I offered many times to buy certain medical needs, but they won't allow it. Health SErvices tells me that a mattress support is not allowed by security, but when I write to the Warden he states that Health items are left up to Health Services, and that sort of runaround is the norm.

In the past 7 years here at the Fox Lake Correctional Inst. I have heard of many medical abuses and extreme neglect to inmates. I could also go into cases of inmates being severely beaten by other inmates and one being turned into a vegetable, etc..., but thats a different type of neglect. There are numerous older inmates with heart problems who get little or no care, and I am aware of numerous deaths at this place, because of neglect. An inmate named Kimpble or something like that died around 1995. I knew him for a number of years. I had seen him a couple of hours before his death. I was told that he didn't get his asthma medication when he was suppose to, but it was written off that he died from his own vomit. I had written to Wisconsin C.U.R.E. about it, but these things become a moot issue after DOC investigates I watched another inmate die a long slow and painful death from cancer. HIs name was Terry Golowski. He tried for a long time to get help for symptoms, but as usual they tell you to take pain pills or drink a lot of the polluted water here. Eventually his symptoms turned onto full cancer. They gave him treatment for awhile, but then a some point

his treatment was stopped, and he was sent to the infirmary at Dodge I had provided Terry with a number of possible and proven cancer cures, some holistic, but they would not allow him to try any of They would not even allow him to go home and die with his family, or die with some dignity. In another situation in the past year an inmate got a visit, but when they went to get him he was dead. a known breathing problem or lung condition, and even his work Supervisor tried to get him help, but my understanding is that HSU said he was faking it. Cedric Johnson here at Fox Lake is another recent example, and I have first hand knowledge in this case. He has a liver condition, and was told a couple of years ago that if he didn't get a liver trans= plant he would die in 5 years. DR. Daley who is in charge of prison health care took this man off the transplant list, because he had a drinking problem years ago before his incarceration. He recently went to court and won a law suit against Daley. He was put back on the list, and if he doesn't get a transplant in two years he gets more money. In the above case with a lung problem I believe his name was Dave Schuiarman. It wouldn't be hard to come up with more situations, but here its hard to learn of an incident unless your right there, or someone you know has first hand knowledge.

In writing this letter I'm not asking for help for myself I'm just trying to make you aware of whats going on, and that it could be on a large scale. This women should not have had to die to bring about an awareness or change in prison health care, as the standards are already there. What needs changing is attitude that starts from the top. Its like Bambi said treatment to inmates is mental sodomy, or as I say, "They demoralize you, Dehumanize you, and then play with your emotions", and that seems to be the prevailing attitude towards those in prison. How can they possibly provide adequate health care here when the ratio is over 1200 men to one doctor, and even dental care can take up to a year to get an appointment!

AFFIDAVIT

Affiant undersigned states and avers to the following:

- 1. Affiant was an inmate at Racine Correctional Institution and from May 5,1999 until released was placed in segregation in the Waukesha Unit and thereon observed the following:
- 2. Affiant states that Inmate Mark Pfeiffer was transferred from the Kenosha segregation unit to the Waukesha unit, so that he was able to receive more medical neglect and shown more deliberate indifference by D.O.C. Staff.
- 3. Affiant's cell was directly across the hall from Inmate Pfeiffer's cell and on May 22nd seen his emergency red light on and after a long period of time a guard responded, whereon Inmate Pfeiffer requested help by explaining that he was choking. Affiant heard the officer tell Pfeiffer to get a drink of water and lay down on his bunk and be quiet. Pfeiffer did not receive any medication, or observation of further help.
- 4. Affiant states that on May 23rd, he observed Pfeiffer's red emergency light was on for over one and one half hours before an officer responed and Inmate Pfeiffer had his arm out the trap door with a show of blood on his forearm and I thought he might have slit his wrist or otherwise injured himself from the pain he was experiencing. The officer stayed less than 30 seconds and left without administering to him.
- 5. Affiant states thaton May 24,1999 Pfeiffer's emergency light was on for about an hour and forty minutes before the guard checked on him and he didn't open the trap door, but talked through the door. At that time Inmate Pfeiffer was lying down on his floor. The guard provided no help, nor did he summon help.
- 6. Affiant states Inmate Pfeiffer's light was on for an emergency on May 25,1999 from 12:00 noon until 1:30p.m. with no response and at 4:20p.m. a guard arrived and ordered him off the floor and observed Inmate Pfeiffer bleeding, but took no action to help.
- 7. Affiant states at the time of 4:20p.m. a 2nd officer arrived and kicked his door and started to walk away, Inmate Curtis Celske said, "feed that man he hasn't eaten for three days." The guard replied, "shut your mouth or you won't eat."
- 8. Affiant states that Inmate Pfeiffer never ate in four days and couldn't get off the floor to get to his bunk. At 8:20p.m. no light was on in Inmate Pfeiffer's cell and one officer was at his door and that one officer called to another officer. The first officer was mute and the second officer said, "Doesn't look like he is breathing." By then a third officer had arrived and said, "He isn't." A fourth officer ordered the door opened.
- 9. Affiant states that H.S.U. was called and arrived n less than ten minutes. Later an oxygen mask was put on Pfeiffer and from that time until the Sheriff came in about thirty minutes and the paramedics arrived about twenty-five minutes after H.S.U. Security Director Ellerd came about this time.

- 10. Affiant states the paramedics strapped Pfeiffer to a board and tied him down and handcuffed and shackled him, while he laid on the cement floor in his cell block in Waukesha West apparently dead, while they were shackling him and manacling him. He lay there on the board while these officials examined the cell and videotaped the cell for about 18-20 minutes. Captain Monart arrived and spent time observing and he was there before the Security Director, who came 15 minutes after Captain Monart and forty-five minutes after the discovery of the death.
- 11. Affiant states that he was released from the Kenosha Unit on 7/16/99, but detained on temporary lock up [TLU] until 7/20/99 and was locked up pending transfer approved by P.R.C. early recall on 7/27/99 with the decision to move Affiant to Fox Lake Correctional Institution and thereafter locked up Affiant in Rock South for 35 minutes and 3 members of the goon squad and Captain escorted him to Kenosha Unit for yet another lock down [with no explanation] pending transfer on 7/29/99 by violating D.O.C. procedure.
- 12. Affiant states while still in Waukesha Unit after the removal of Pfeiffer's dead body, Inmate Walter Lamacki #268904 was assigned to clean up the blood and other body fluids of Inmate Pfeiffer, which included the blood on the trap door, toilet, floor and bed.
- 13. Affiant states almost immediately after clean up, a new Inmate, William Epker #335094 was in fact moved into this cell.
- 14. Affiant states that thereafter District Attorney Robert Flincher found two officers guilty of misconduct in office.
- 15. Affiant states that he has attempted to contact Inmate Pfeiffer's relatives to inform them of these events and that he would be willing to testify in court of these observations made of the medical neglect and deliberate indifference shown to Inmate Pfeiffer by these officials subjective recklessness in creating these malicious injuries.

First of all, let me thank you on behalf of ALL inmates regarding your interest in looking into the DOC's health care problems. It is a long time in coming and MUCH needed!
