
FACT: Nearly 70 percent of incarcerated individuals committed a crime directly or indirectly related to substance abuse.

FACT: In 25 years of studies, no evidence has been found that criminal justice sanctions alone, without treatment, have any effect on reducing drug use and crime.

FACT: For every \$1 invested in treatment programs, taxpayers enjoy a \$4 return in the reduction of drug- and crime-related costs.

Simply put, alcohol and drug abuse are directly or indirectly responsible for the majority of the criminal offenses in this country. That reality is costing society millions of dollars each year, as well as immeasurable amounts of pain and suffering through victimization and loss of life.

CA HAS DEVELOPED
A SUBSTANCE ABUSE
TREATMENT PROGRAM
THAT IS SUCCESSFUL,
COST-EFFECTIVE AND
IDEAL FOR A CORRECTIONAL SETTING. The program
is called LifeLine, and it uses a long-term,
therapeutic community approach to:

- eliminate drug addiction,
- change an individual's attitude, and
- modify a person's criminal behavior.

LifeLine is long-term treatment for long-term addiction. The comprehensive program lasts a minimum of six months because it takes that long to effectively deal with an addiction and to significantly change a person's attitude.

The program is an intensive and highly structured one. When someone joins LifeLine, he is housed with the other program participants in a special living unit at the CCA facility. The inmates live, learn, grow and receive treatment together.

IFELINE HAS THREE
PHASES. INITIALLY, THE
TREATMENT DEALS WITH
THE INMATE'S ADDICTION,
BUT MUCH MORE TIME IS
SPENT ON CHANGING THAT
PERSON'S ATTITUDE. Most
inmates blame everyone but themselves
for their criminal behavior. LifeLine doesn't
accept excuses. Instead, responsibility,
accountability and willingness to change
are demanded.

In phase two, LifeLine teaches and trains inmates how to solve problems, set goals, develop morals and communicate, among other necessary skills. Treatment methods include confrontation sessions, in which residents are challenged by their fellow inmates for failure to deal honestly with themselves and their problems. For many, this may be their first experience in overcoming anger and developing discipline.

The third phase of LifeLine focuses on the 12-step program, which provides basic guidelines and rules for daily living. Upon successful completion of all three phases of the program, an inmate graduates from LifeLine.

INCARCERATION. Upon an
inmate's release to society, CCA staff
work with local social service agencies to
provide after-care and follow-up treatment,
which are crucial to the program's overall
success rate.

The effectiveness of a therapeutic community treatment program like LifeLine is well proven. Studies show that therapeutic community graduates are much more likely to find employment after release and are less likely to become involved in drug use and criminal activity. Combined with CCA's other educational, vocational and work programs and services, LifeLine graduates have a much better chance to become productive members of society after their release.


We further commit ourselves to being the type of men who will teach others by

TIVE. Through a treatment approach like LifeLine, the demand for drugs decreases, criminal behavior is reduced, and taxpayer dollars are saved. Judges and other criminal justice officials agree, as they increasingly require the program in sentencing. In addition, research shows that court-ordered referrals to therapeutic community programs have better success rates than voluntary participants.

A different attitude and lasting change are the true measurements of LifeLine. In the words of a LifeLine graduate who recently was released from prison, "I feel the program is the best thing that has happened to me in many years . . . LifeLine is going to keep me from living life my old way and keep me from returning to prison. Thank you for this program."
